

SAFE ENVIRONMENT FACILITATOR TRAINING WORKSHOP

The Office of Child and Youth Protection invites you to the upcoming Safe Environment Facilitator Training.

The Diocese of San Bernardino has partnered with CMG Connect to provide comprehensive safe environment training for adults.

Recent updates to the diocesan safe environment policy and training method require all previous Safe Environment Facilitators to renew their training and commitment. **NEW Safe Environment Facilitators are welcome!**

A Safe Environment Facilitator is assigned by the Parish Pastor/Administrator or Principal to be trained and certified by the Office of Child and Youth Protection to facilitate safe environment training for adults at the parish or school.

Live in-person trainings can be offered at parishes and schools only by certified Safe Environment Facilitators.

Safe Environment Facilitator Certification Requirements

In order to receive a Safe Environment Facilitator Certification, participants must meet the following requirements:

- Be assigned by the Parish Pastor/Administrator or School Principal. Certification will **not** be granted to participants that have not been approved by their Parish Pastor/Administrator or School Principal.
- Complete the Diocesan Safe Environment Training, either online or in person, using a CMG Connect account, **within the last three months**.
- Have a satisfactory California DOJ/FBI Live Scan Background Check on file with the Diocese of San Bernardino.
- Register for an upcoming Safe Environment Facilitator Training using your CMG Connect account.
- Complete the Safe Environment Facilitator training provided by the Diocesan Office of Child and Youth Protection.
- Sign the Affidavit of Confidentiality and Ethical Standards, which will be provided at the end of the Safe Environment Facilitator training.
